**Re: Procedural Request – Review of video relay service, Telecommunications
Notice of Consultation 2021-102**

This is a procedural request by the joint party of the Canada Deaf-Blind Collective Video Relay Services (**CDBC.VRS**) and Deaf Wireless Canada Consultative Committee (**CDBC.VRS-DWCC**) regarding a deadline in the above-noted proceeding, pursuant to section 7 of the *Canadian Radio-television and Telecommunications Rules of Practice and Procedure*.

Due to unforeseen circumstances, several key colleagues cannot fully participate in our joint discussions about this important matter.

CDBC.VRS-DWCC respectfully requests that the CRTC briefly extend the deadline for replies to interventions, either for all parties or for our joint party specifically, to 8 August 2022.

We are keenly aware of the importance of this proceeding. We respectfully submit that granting our request will enable more careful consideration of the information and arguments presented by the participants to provide the CRTC with a thoughtful and informed reply concerning their interventions. Bearing in mind that the complexity of the VRS issue has already lengthened the proceeding somewhat and the fact that we are in the midst of the summer months, we do not believe a brief delay will unduly disadvantage any party.
